# Secretary's Report

To Members of the Western Australian National Football League Umpires' Association.

Gentlemen,

On behalf of your Management Committee, it gives me pleasure to submit for your consideration the Annual Report for season 1983.

To a large degree 1983 has been a year of change, with a new Advisor and Assistant Advisor, new Training Supervisor and Country Advisor and an almost newly formed Appointment Board.

The number of opportunities given for members to gain promotion throughout the season was no doubt due to these new appointments. Five Field and four Boundary umpires achieved their first league appointments and this must surely be a record in the history of the Association and the WAFL.

Prior to the commencement of the season we saw the retirement of our two senior field umpires in Ross Capes and Ron Powell and the senior boundary umpire in John Devine. Fortunately, they have all decided to continue in the umpiring sphere and their experience and wealth of knowledge will be beneficial to us all.

This year, for the first time, WAFL umpires were sponsored. I believe that this overdue arrangement came to fruition largely due to the suggestions of the Association and we were indeed pleased to see our generous friend Ampol Ltd. gain the sponsorship rights. We trust that we have provided them with suitable exposure and we look forward to further development and continuance of the sponsorship contract. We are particularly grateful for that part of the sponsorship that flows directly to our members by way of the Ampol Awards.

In the 1982 Annual Report I emphasised the need for club officials to exercise more responsibility in their criticism of umpires and for the WAFL to police this increasing and undesirable trend. Unfortunately, during this season we again witnessed further instances of this irresponsible behaviour. The action taken by the Management Committee, as a result of the comments made by East Fremantle FC officials, was done so after much deliberation. It was pleasing to note the united stand of the members on this issue, which was further confirmation of the Association's refusal to accept unjust situations whether they involve individual members or the Association as a whole. The time is long overdue for the WAFL to either follow the example of the VFL and inflict an immediate and substantive penalty or alternatively allow open public criticism of its umpires by all club officials.

1983 saw the introduction of *The Whistle*, the Association's newsletter. Due to the diligence and expertise of its Editor and his imaginative team, *The Whistle* has been well received by the members and we all look forward to its reappearance in 1984.

#### PRESIDENT

John Morris, our President in 1983, provided sound leadership in his first year and has no doubt gained a lot from the experience. John carried out his duties in a diligent manner and always had the interests of the members and the Association as his main goal. Congratulations John, from all of us, for a job well done.

#### **VICE PRESIDENT**

David Rowe, our Vice President for the past two years, provided capable support for the President. The experience he has gained in this position should stand him in good stead for eventual Presidency of the Association.

#### TREASURER

In his first year as Treasurer, Rob Hendrie has managed our financial affairs in a most professional manner. We look forward to the benefit of his efficiency again in 1984.

#### SOCIAL SECRETARY AND COMMITTEE

During 1983 the Social Committee provided an enjoyable and successful calendar. Ken O'Driscoll in his first year as Social Secretary, with the assistance of his committee, endeavoured to introduce new ideas. In some instances they deserved better support from the members for their untiring efforts.

#### MANAGEMENT COMMITTEE

Under the Presidency of John Morris, the Management Committee strived to handle the business of the Association in a competent and effective manner. The input provided by new members in Max Hale, Rob Hendrie, Gil Bishop and Damian Green was both innovative and welcome. Collectively, the Committee endeavoured to put forward progressive ideas for the betterment of the Association and its members. To each of them, for their assistance and co-operation throughout the year, I am extremely grateful.

#### UMPIRES' APPOINTMENT BOARD

The Umpires' Appointment Board was most fortunate this year to be capably chaired by Mr 'Slim' Somervaille. Slim displayed an earnest enthusiasm and refreshing approach to his task. Moreover, he made a genuine attempt to identify with the rank and file members. With new members in Messrs Capes, Powell and Collett and existing member Peter Pustkuchen, the Board showed ample evidence of their preparedness to provide opportunities and take a chance. This is something that has been sadly lacking in the more recent years.

With the material that is available in all three categories and providing honesty and consistency prevails, the Board's deliberations in 1984 should meet with the approval of all.

#### **UMPIRES' ADVISOR**

Ross Capes in his first year as Umpires' Advisor, brought with him several new ideas and has no doubt learned a lot during the season. The opportunities provided this season for new umpires to officiate in senior football are directly attributable to Ross. The transition from being one of the boys to that of Advisor is not an easy one and Ross is to be commended for his capable handling of the situation. Additionally, Ross has remained a strong supporter of our Association and we look forward to his continued involvement. Ron Powell in his role of Assistant Advisor provided valuable support for Ross and was always on hand to give advice and guidance to all members of the panel. **TRAINING SUPERVISOR** 

John Devine had the responsibility of looking after our physical fitness during 1983. As with his approach to boundary umpiring, John tackled this new task with professional dedication that provided us with a refreshing new approach to training. The decision to separate the city and country panels and to allow the goal umpires to be self supervisory was a sound one and enabled the Training Supervisor to concentrate on a smaller specialised group. John will no doubt have some new ideas for his second year and we look forward to his guidance in 1984.

#### **COUNTRY ADVISOR**

Another first in 1983 was the appointment of a Country Advisor. For many years Ned Martino has carried out these duties in an unofficial capacity and it was fitting that he should be the first official Country Advisor. Ned's loyalty to the Association and umpiring in general is unsurpassed and his popularity in the country areas is well known. We look forward to him continuing in this important role.

#### **UMPIRES' ADVOCATES**

The ranks of our advocates were somewhat thinned this year with the appointment of Messrs Ray Montgomery and John Dolling to the WAFL Tribunal. This naturally put a greater workload on John Smith-Gander and Charlie Pratt. Nevertheless, they continued to provide our members with competent advocacy and to each of them we are extremely grateful.

#### TRAINING STAFF

Head Trainer Warren South and his industrious team of Harry Jardine, Bernie Magnus and Doc Doherty once again took care of our aches and pains. To each of you, on behalf of all our members, I extend grateful appreciation.

#### HONORARY SOLICITOR

Again this year the Association was indeed fortunate to have the services of Dwyer, Durack & Dunphy. We are particularly indebted to Simon French and Rene Lucien Le 'Mere for their continued professional assistance and advice.

#### HONORARY AUDITOR

Mr Brian Eddy continued to perform the role of Honorary Auditor and did so in a most precise manner. We are grateful for his sound professional advice.

#### **AMPOL LIMITED**

As in previous years, Ampol again made available a handsome array of valuable trophies. We are all most appreciative of their continued support and especially thank Mr Tony Rapson and Mr Ross Benzie.

#### POINT PERON CAMP

Still the most popular gathering of the year. Its popularity is undoubtedly due to the organising ability of Hal Symons, who was again capably assisted by his band of hard working senior citizens. This year the WAFL covered the cost of the Camp and this kind gesture is deserving of our gratification.

To the past and current Presidents in Messrs John Devine and John Morris I extend my particular appreciation; to the Management Committees of the past three years my thanks for their support. Finally, to you the Members, I thank you for the opportunity of serving the Association in this capacity.

Finally, we should all understand that the future success of the Association will not be achieved without the fullest support and co-operation of us all. It is the duty of each of us to take an active interest in the Association's affairs.




# **Kevin Cox Memorial Grant**




# **Ross Capes'** Look at '83

The 1983 season concluded with 3 umpires officiating in their first League Grand Final - a pleasing result for the newly appointed Umpires' Coach and Appointment Board. Equally pleasing was their performance, which together with their teammates, justified their selection.

Looking back over the season some bold initiatives were taken by the Board and I would like to review them with you.

(1) Avising all 1982 umpires the commencement date for training and what was expected of them in regard to fitness plus an invitation to apply to umpire in 1983.

#### Comment

This was well received by all and created a great deal of interest and competitiveness during the summer months. The later start to official training for most was also appreciated.

Similar procedure is planned for 1984.

Two weeks of specialised training for a select group. (2)Comment

Under supervision from Hal Symons this additional training appeared to be well received and of some benefit to those who participated.

Plans are underway for further specialised training in early 1984.

(3)One field umpire in Colts.

Comment

This gave the Board a clear indication of the abilities of those umpires used in this grade. In the main those used were young umpires with potential to umpire League.

Its success was moderate, as it became obvious that umpires had difficulty in maintaining tight control on their own and a high degree of fitness was required.

A recommendation that the 2 umpire system return to Colts in 1984 has been put to the League in my report to that body.

Two separate training groups. (4) Comment

> This move created some discontent among umpires. However, it was necessary in view of the difficulty in training a group of over 90 umpires at one time under one person.

Similar action will be taken in 1984, with some refinements.

(5) Umpires' reports discussed with the Board member direct.

#### Comment

The willingness of the Board members to discuss their reports with the umpires direct, created a greater awareness of what the Board were looking for with the result being a more uniform report and the umpire was left in no doubt on how his performance was viewed.

A closer understanding of each other's role also resulted. This sytem will be undertaken again in 1984.

(6) Less meetings - more information given on the Board's activities and policies.

#### Comment

All umpires appreciated being kept informed of what ideas and policies the Board had and the reduction in the number of full meetings held was well received.

Continuation of the format is planned in 1984.

(7) Roster system.

#### Comment

Whilst not receiving support from all umpires, it was generally agreed to be a fair and equitable system and one which provided more umpires the chance to officiate in a higher grade.

The roster system will be used again in 1984.

(8) Law interpretations — some were altered, in particular the two umpire system.

#### Comment

Changes made were supported by most umpires and were in the main correctly carried out.


Further changes in interpretation will be made in 1984 in addition to a couple of suggested law changes.

#### SUMMARY

All in all the Board viewed 1983 as a trial year. Not all that was implemented met with the success that we expected, however, it has given us a very solid base from which to work in 1984. I trust the League will support my recommendation to retain the Appointment Board in its present form, so that the views expressed during 1983 can be followed through into 1984.

To all active umpires, I wish to take the opportunity on behalf of the Board to express our appreciation for the support we received from you all in 1983 and trust that 1984 offers you a challenge which you will take up and endeavour to reach the heights in umpiring that you have set yourself.

### **Devine Fitness** By the Umpires' Physical Education Coach — JOHN DEVINE

With season 1983 behind us it is important to reflect on our performance on the track with a view to improvement for 1984.

I have certainly gained considerably from the experiences of 1983 and appreciate the difficulty of training a large group of runners at the one time. There is, naturally, a wide variance of capacity and ability between our members and it must be recognised that some will never reach the performance excellence of others, based purely on the gift of natural ability. Nonetheless, the majority

of us who have been endowed with average ability can certainly become top performers through dedication and application to training.

Self motivation to improve one's performance, coupled with the training expertise required, will produce remarkable results and this was admirably borne out during the short pre-season sprinting sessions under Hal Symmons. The improvement by all who participated was clearly evident.

We need the technical expertise but success or failure will depend largely on our self motivation and single mindedness to strive for high personal achievement. We should now be setting our goals for season 1984 and our physical fitness will play a major role in achieving these goals.

With the end of season 1983 it is important also to review the state of our bodies. Almost without exception we will need a few weeks of rest to let our bodies recover; for those minor tears, aches and pains to clear after nine months of continuous training.

If you have been "carrying" any type of injury which has persisted seek advice from a doctor who is well versed in sporting injuries. Don't delay — remember that the most common cause of sports injuries results from overwork.

It is suggested that your usual running routine be changed during the months of October and November by restriction to "easy runs" of between 5-8km. Concentration on swimming, bike riding, tennis or squash during these two months would be a worthwhile supplement.

I expect that training will not commence prior to mid-January at the earliest; accordingly, it is recommended that your concentration on running be increased in early December and after a few weeks of building up the mileage, at least one day per week be devoted to faster work — suggest fartlek style.

Flexibility exercises should be continued throughout the off-season and their intensity and range progressively increased from the start of December. Weights for the upper part of the body certainly wouldn't go astray. The *gradual* build-up from December should have us all well placed to perform more than satisfactorily in the 15 minute run, scheduled for the first official night. With that level of fitness beneath our belts we can confidently face season 1984.

Gone are the days when one could turn up in early Janaury and think about getting fit for the approaching season. A reasonable degree of physical activity must be maintained off-season to ensure basic fitness is held. The later start to pre-season training makes it imperative that everyone arrives with a sound preparation. Overweight or ill-prepared bodies will not be tolerated in 1984. It is purely a matter of planning which will be relative to the degree of commitment we have to succeed in our umpiring careers.

Good running into season 1984.

### **1983 Annual General Meeting**

The Annual General Meeting of the NFLUA was conducted on Saturday, 8th October, 1983 at Football Park in Canberra.

Delegates from all States and Territories in Australia represented their respective Associations, with request for representation from New Guinea and New Zealand being denied because of their controlling bodies not being affiliated with the NFL.

The meeting which lasted for five hours covered a diverse range of topics, some of which are outlined for your information.

#### They are:

- 1) Peter Bunworth (VFLUA President and NFLUA Secretary in 1981-82-83) was voted as the inaugural life member of the NFLUA. A Medallion was to be cast and presented at a later date.
- 2) Proposed AFC Fee Schedule 1984:

3) Further representation to the NFL requesting a boundary and goal umpire officiate at AFC interstate matches.

- 4) Affiliation fee from each State to remain at \$60.00 for 1984. Annual General Meeting next year to discuss possibility of this fee being based upon a levy of \$1.00 per member, so as to ease the burden on minor States.
- 5) An NFLUA magazine to be produced, initially by W.A., early in 1984 with each State contributing. This, besides giving a comprehensive view of umpiring throughout Australia, will provide contacts in each State, enabling umpires travelling interstate the opportunity of training and socialising if they so desire. This would be applicable in and out of season. Australia-wide sponsorship to be sought to cover printing and postage.
- 6) Possible registration of umpires in Australia. Details of umpires, such as games, etc. to be supplied at the end of the year to the NFLUA. This information will be collated and will be readily available to affiliated associations if members transfer from State to State, etc. Further discussions to take place.
- 7) NFLUA to write to State bodies somewhat behind in match payments to umpires, requesting prompt settlement. New South Wales reported that since a letter to their controlling body last year, payments have been on a regular basis.

It was apparent that each State/Territory was keen for the NFLUA to become more active in representing umpires or disband completely. It was a unanimous vote that the association become more active in controlling and promoting the affairs of umpires throughout the nation, and as such, it is my recommendation as the 1983 delegate that the concept of such an association be positively accepted by all members of the WANFLUA.



### **Treasurer's Report**

#### Gentlemen,

I have pleasure in presenting the 1982/83 Treasurer's Report including the Receipts and Payments, Income and Expenditure, Balance Sheet and Auditor's Certificate.

The accounts reveal a deficit of \$205.00 of income against expenditure after allowing for \$250.00 against plant and equipment (typewriters) written off during the year.

Debtors totalling \$650.00 and appearing in the 1982 financial statements were not fully paid and have been adjusted in this year's accounts as follows:—

- (i) **Grand Final Dinner Dance \$400** \$20.00 was not recoverable due to a single payment owing in lieu of a double and this amount has been included in the expenditure figure for this year's function.
- (ii) **Rottnest Island Trip \$250.00** \$6.00 was retained by the Island Board from the bond for a damaged window and this amount has been included in the costs under income for this year's trip.

As can be seen by the receipts and payments figures, our turnover for the year almost doubled, up **\$31,485** from **\$34,285** to **\$65,770**. Attributed to this is the increase in number of social functions held, the opening and closing of a separate interest earning working account and the old problems of spiralling costs. I believe the Social Committee should be congratulated for the tremendous results they have achieved this year in having the majority of members participate in the numerous social activities and thus strengthening our Association as an individual body.

Your Committee was keen to promote as many social functions as practicable on a "break even" or subsidised basis and the fact that this was achieved with the culmination being our Grand Final Dinner Dance, attended by some 225 people at a cost to members of only \$40.00 per double, speaks well for the organisation and thrift of that committee.

A new innovation this year was the introduction of deductions from fortnightly pay cheques into a savings account of the member concerned which gave provision of funds to that member for required payments throughtout the year. This method proved most successful and benefited all concerned and I would recommend to those of you who did not elect to adopt the practice this year, to give it a try in 1984.

The "20" Club was our main income earner, apart from subscriptions, and this venture was a welcome departure to you all, I'm sure, from those normal dreary raffle books. Although somewhat time consuming to myself, the 20 Club was a popular change. A total of \$138.00 remains outstanding in payments and whilst the majority of this amount is expected to be collected, I have not included the sum into the income figures due to the uncertainty of the final amount which will be received.

Whilst the Reserve Investment Account shows a healthy balance of \$6,589, up \$948 (16.8%) I would recommend to you all that this account be left to accumulate interest and be used for special cases only, as chosen by your committee. I do not believe

that this amount should be kept as a set amount of, say \$5,000, with the interest being used to subsidise our working account. Our reserve funds need to at least keep up with inflation and any surplus beyond that figure should be spent only if required. The results of our 1982/83 year prove that this is possible.

On the matter of inflation, subscriptions will need to be increased for 1983/84 to cover running costs and also allow for the incoming Social Committee to budget for next year's functions in the same manner as they have this year. The important aspect of increased subscriptions is that you, the member, are the beneficiary in the long run, as any surplus funds at year end are utilised towards subsidising the Grand Final Dinner Dance. I recommend to you, for your consideration, an increase in subscriptions for the 1983/84 year to \$30.00.

My personal thank you and best wishes go to Don McComish, our retiring Secretary, who has been an inspiration to your committee and a tireless worker for our Association during his three-year term.

Once again Brian Eddy has audited our books in an honorary capacity and for his time and efforts 1 am most grateful.

I look forward to taking your money off you again in 1984.






see their heroes in action. This event capped off a generally successful social year and your support throughout 1983 was most appreciated.



### Ned's Message

As country umpires' coach, I consider the formation of a city and country umpires' panel was in the best interests of football, particularly when you consider that there are a number of capable umpires who will never be given the opportunity of umpiring league football. This change has a twofold benefit: it enables the city panel to be given the most professional expertise, both in the advising and training areas; it also gave the umpires who were travelling to the country every week the opportunity of umpiring inter-association and final round games that normally would have been awarded to the league or reserves umpires.



During the season I was involved in a number of

coaching clinics in the country areas, e.g. Port **Ned Martino** Hedland, Albany, Northam, Bruce Rock, Geraldton, Three Springs, Moora, Bencubbin, Katanning and Karratha.

In the main these proved popular and were well attended. I always encourage administrators, media representatives and coaches to attend, stressing the role of the umpire, emphasising that the umpire is a vital and integral part of Australian football, contributing to the game in the same way as the players. Administrators, coaches and media representatives in particular should promote the game by highlighting the most spectacular and exciting aspects of our game, and should expose player errors on television, and in radio and newspaper coverage rather than continually criticising and replaying umpires' controversial decisions.

Training sessions and lectures were conducted for the umpires in the various country centres keeping them up to date with interpretations and emphasising the importance of fitness and positioning and to use the ground markings as an aid to judging distances, e.g. 15 metres, 10 metres and running to positions.

In addition some areas conducted coaching clinics for juniors. I lectured on the main laws, stressing the importance of the ball player and the protection the umpire gives him and then emphasis on the tackling player, stressing the importance of correct tackling to minimise the risk of injury and incurring a penalty.

I consider these to be of immense value to the junior player in understanding the umpires' role and the importance of playing within the laws of the game.


