President's Report


With the 1996 season completed and having taken the opportunity to reflect I must admit that my second year as President proved to be extremely tough. Time and again issues raised their head that proved very difficult to handle and at times during 1996 it would have been easy to just walk away and leave the job to someone else. But every time this thought entered my head it quickly disappeared when I realised the positive effect this Management Committee has had on the overall well being of this Association. Clearly the Management Committee in 1996 wished to follow on from the foundations laid by the 1995 Committee and with this raised level of commitment comes naturally a higher level of expectation from the members we serve.

Having said that, 1996 provided many highlights.

The Amateurs got on board at Ernest Johnston and this was in my view a step in the right direction for umpiring in general. It provided it's own set of problems. Member dissatisfaction was at an all time high for many months as problems surfaced with two large groups attempting to co- exist in premises that did not have the capacity to deliver. Much of that blame can be thrown at myself. Some very poor preparation and a lack of real direction as to how the two groups could work together in the end caused many rifts between the two groups, many of them unnecessary. Given a better plan and greater more effective consultation with the respective Management Committees it could have worked.

Many lessons were learnt from this episode and in the future if another opportunity arises like this one we won't make the same mistakes. My personal view is that for an Association like ours to expand it's growth and understand that membership continues to fall for various reasons, some type of affiliation is inevitable. Whoever is in the drivers seat the next time an opportunity arises should work harder for a positive result.

Renovations to the social rooms continued in earnest in 1996 starting with a fresh paint job on the inside of the rooms kindly donated by Don Wakenshaw from Eric Hood. An alarm system and Kresta blinds were fitted to aid security and Cameron Dawe helped to provide new lighting more of which is being installed as I write. To Don and Cameron many thanks.



The Management Committee decided this year to start a black and white photo collection of umpires in action. All umpires were asked to submit photos they thought would suit the social rooms and many provided some outstanding snaps. Those selected were copied, enlarged and now adorn the walls of our social rooms. It's fair to say that these photos have really added to the club atmosphere we have attempted to generate.

Other highlights included the induction of three new umpires to the Hall of Fame. Recognised now as a prestigious award the three inductees all proved to be very worthy recipients. To Mike Ball, Dave Aslett, and Roy Becker congratulations.

The formation of the Grand Final Umpires Club in 1996 was in my view our most significant new contribution to the umpiring group. With an amazing amount of leg work by a few committee members we managed to contact all 103 Grand Final Umpires since our incorporation in 1953. Of those 52 accepted the invitation to attend the inaugural dinner held at the Barry Cable Room, Subiaco. Judging from the response we received from all those who attended and the many who could not it will quickly entrench itself as one of the best functions in years to come. Hosted by Brad Hardie it was a fantastic opportunity for many old friends to reacquaint. Each member of the new club received a Grand Final Umpires Club badge and five new members were inducted, capping off a big night.

To top the year off nicely we had our first representative participate in an AFL Grand Final. Dan Gooch proved during 1996 that he was clearly the best boundary umpire going around and was rewarded with a Grand Final appointment.

Finally may I pass on some thank yous to my management committee. Peter Frusher came back after a absence from committee work and proved to be a tower of strength. His work around the social rooms was second to none and I thank him very much for his support in 1996. After a number of years serving on the Management Committee two senior members have elected to stand down. To Sam Kronja and John Hauswirth I pass on my best wishes and thank you both for some outstanding work and it will be extremely difficult to replace these quality people in the years to come. Darren Starcevich again carried out his duty as Secretary with the utmost professionalism and I look forward to working with Darren again next year. John Marrapodi, Dan Gooch, Brett Wallington, Aaron Capes, Neil Morfitt and Tim Priest all proved to be valuable assets to the Committee and I pass on my thanks to all of them.

To David Johnson, I pass on a special thanks. David has a very clear view on what the Association is trying to achieve and it has been with his support and encouragement a lot easier for the Association to achieve it's objectives. The Management Committee look forward to continuing it's solid relationship with David in the future.

1997 will no doubt continue to throw up new challenges for the Association and I look forward to leading the group again in what promises to be a very exiting era for the WAFL competition. Enjoy the break and may we all come back in the pre season ready to move onto bigger and better things in 1997.

We bandy the phrase 'Club Atmosphere' around almost as often as we call 'play on' but what does it really mean. And more importantly does the WANFLUA represent a club or are we just kidding ourselves with an idea and ideal that can't exist because of the sport we are in.


Let's look at the first issue here. The WANFLUA as a club. What does it mean - is it just a bunch of blokes who see each other 3 times a week?

All Associations need strong leaders and hard workers. Greg Scroop, in his second year as President, is directing the ship like never before. The social rooms are a place of umpiring history and people want to see what we have. Once again Greg has mixed the role of President with on field performance and is the leader of the 'club'. The summer will see many changes-possible affiliation with the Peel Football League Umpires Association, extension of buildings and renovations at Ernest Johnson and Greg will be working as harder than anyone to ensure that we move forward in giant steps.

Peter Frusher is a 'club' man. He has performed an outstanding job as Vice President in assisting Greg and has single handedly coordinated, and in many instances done himself, the improvements to the buildings at Ernest Johnson. Add to this Peter's work on the Life Pass for past members of the club. This is what it means to be a 'club' person.

In 1996 we enjoyed ourselves at the Movie Night, waxed lyrical over new 90's style Association ties, stood tall when we saw ourselves on honour boards, read about ourselves in the Football Budget and extolled the virtues of the Hall of Fame and dreamed one day of being presented with a caricature at a packed Ernest Johnson. All these roles were filled by one person in 1996 - your Life Members Trophy winner Tim Priest. Tim captures the essence of what it means to belong to the 'club'. That no matter what the situation or the personal feeling, the club comes first. Yes we might just have a 'club' here.

Before reading further, ask yourself this question - 'How many years has John Hauswirth served on the committee of this Association?' The answer is 7, by the way 3 of these as Social



Secretary. It was a pleasure to work with John. He will not take a role on the committee in 1997 - I couldn't understand why until I saw the work he put in this year. Attendance's at social functions are ever increasing. The move to merge the Presentation Night and Grand Final Dinner was a master stroke. Yes, we are a 'club'.

Sam Kronja took a shoe box full of scraps of paper this time last year and now provides up to the minute financial accounts of the Association. His organisational qualities mean that whilst Sam Kronja can't serve on the committee in 1997 he leaves it in a better shape than when he arrived.

One specific secretarial role that I undertook in 1996 was to capture a piece of our history by compiling the WANFLUA League Games List. A couple of days later what I had was as complete a list as possible of the 500 or so umpires who had umpired a WAFL and/or AFL game in our history that began in 1953. We could then compare ourselves to the greats 'How long before Vernon gets to Montgomery?', 'How many Grand Finals did Carter and Rose do?' and 'Terry Neilson's a Life Member and he only umpired 1 League Game!'. It was the most satisfying and enlightening tasks I have ever done - and that's not a joke!

In 1996 the Association instigated a peer system to Tribunal Advocacy. Twenty of your fellow members volunteered to give one Monday night of their time to assist as tribunal advocates - some were needed for several cases on their and some found that they were not required on the night. But these men gave their time

unconditionally to this club and I thank them for that. They also agreed to implement the same system in 1997. This is what it means to be a 'club'.

The honorary medical staff of our Association also deserve some of the spotlight. In a world where the goal posts are constantly changing they are unwavering in their support of umpires and umpiring. Medical benefit funds are putting pressure on our staff to not supply the service they do - but to do that would be 'unclub-like'. To Tony Chamberlain, Richard McMinn, Dr Colin Hughes, Dr Rod Moore and Fabio Egitto - the club thanks you for 1996.

And there are others, too, who work to maintain and enhance our image. Sponsors like Taylor Woodings, AMPOL, John McKay and Don Wakenshaw. Look at the other sponsors in this publication and the gold bricks on the wall and use them - they deserve your support.

Duane Cole left the committee in 1995 but produced the Grand Final lunch at Subiaco Oval. In September the inaugural 'Grand Final Umpires Club Dinner' was held. This was the culmination of many months searching yearbooks, WAFL records and phone listings to track down 101 former members of our club. This is an integral part of our history that can't be lost - someone had to ensure that those men who performed great deeds on Grand Final Day belonged. I met 'Smokey' Woods - 1953 and 1954 Grand Final Umpire and it was all worthwhile. Yes, we are a 'club'.

But be warned - are we a club or are these just half a dozen warm fuzzy stories?

They tell us of 20 or 30 individuals who are club people. But our Association has 95

members. The law of averages suggests your turn will come up 1 in 3 years. Let's hope you're ready and willing when your time comes. I hope, then, that we are a 'club'.


At the Annual General Meeting of 1995 the members voted unanimously to remove honorary payments to its hardest workers. It was easy(soft) to raise a hand but ask yourselves whether you are willing to do the job for nothing. We will be looking at you in the future and you can't just be a hand in the crowd. When Greg Scroop wants an answer you must give him one face to face. I hope, then, that we are a 'club'.

The Taylor Woodings deal is fantastic - they give us shirts, rugby tops, even cash. But they expect a return. And they are good people so they don't openly ask for one. We don't just belong to a club when we put a rugby top on, we are supposed to belong all the time. If we all take a little bit of responsibility we can ensure that company's like this stay on and want to be associated with clubs like ours.

If people like the Greg Scroops, John McKays and John Hauswirths of this club come to visit it in the year 2003 are they going to see 50 years of history, 10 years of Hall of Fame and vibrant Thursday nights - or are they going to see some 'bloody good ideas at the time' floundering because the 'club atmosphere' died? I'll let you in on a little secret - club atmosphere only dies when the members want it to.

We are a 'club' or are we a 'club'? Think about it the next time there's something that looks like it needs doing.

Treasurer's Report

In 1995 the Management Committee released a Strategic Plan document which outlined the direction and policies that would be followed in the running of the Association. One of the goals was to create a 'Club Atmosphere'. 1995 saw us run a programme to raise funds so we could spend money on the club facilities in 1996.

On a comparative basis our cash reserves are \$6,440 lower than this time last year at \$14,455. A more interesting way of looking at things is that last year there was a cash surplus of \$7,487, therefore there is a turnaround of \$13,927 in spending. This is reflected in payment for the photograph gallery, the pool table, new honour boards and the security system to name a few items. The feedback received has been very positive to date and we have impressed the many non-members who have visited the social rooms.

As always there are many questions that members have on the way their money is raised and spent. The current policy of the Management Committee is that we do not want to run any functions at a loss. Making a profit is not always the motivating factor, however we are determined not to waste funds on funding one night drinking and eating binges to the detriment of spending money to improve facilities. Therefore most functions that are held are self funding and are user pays.

This alone is not understood by many members who think that the Association owes them so many functions a year. This mentality is effectively saying that each member contributes \$50 of their \$120 subscription towards running the Association. Based on the subscriptions received this year that leaves \$4,217 to run the Association. Given the bar makes on average a 30% profit, leaving approximately \$3,200, this totals \$7,417. Without self funding functions and events this \$7,417 doesn't go very far.

The effect of self funding functions can be seen in the training camp running a surplus of \$1,229. This was due to a smaller contingent of people attending the camp which significantly influenced the costing. There are grounds to say an across the board refund was in order, however members do get there pound of flesh back in the form of happy hours at the camp and during the year. So don't feel like you are being taken for a ride.



Other self funding functions are the movie night, Grand Final Day Lunch, Grand Final Umpires' Club Dinner, Golf Day and the Umpires' Night. All of these functions were self funding and in general terms brought a surplus. You will find that by matching the income and the expense items that this is not the case for the Umpires' Night and the Grand Final Lunch, however the income figures do not include bar sales which in the final analysis makes the day a success.

Some of our functions cannot be self funding ie: Panel Night, which is largely a subscription funded evening, as well as the Presentation Dinner, however the level of subscription funding will continue to drop in future years.

How will these functions be funded? Good question. I believe we should run a function or two that are designed to specifically raise money for the Presentation Dinner, so for instance members are free. Or maybe some fund raising projects. Too many members whinge that they have to put their hand in their pockets 'again', instead of either offering suggestions or doing something about it. Putting away two dollars a week for the year will go a long way to funding the Presentation Dinner. You are only limited by your own limitations.

Bar trading gave us a gross profit of \$3,217 which represents a gross profit of 30.63%. This return is better than previous years. The profit is a little understated in that the bar is stocked at present and the expense is recorded but as the

stock has not been sold it is future income. However because a fridge has to be stocked before you can sell anything, we must be content in the knowledge that we do have future income to consider. I would like to take this opportunity to thank initially Trevor Cant for his time before his retirement and to John Starcevich for his invaluable time helping us out. Not a bad effort by someone who has never been a member of the Association. Food for thought.

Next year will probably see two movie nights which are cheaper and less time consuming than Quiz Nights, a Gentleman's' Evening and some other yet to be disclosed ideas. Once again I call on all members to contribute any ideas they have. This alone is important as in general terms attendance was very poor at functions that were held during the year. This will need to be improved. One very pleasing aspect was the attendance at the social rooms after training, especially Thursday nights. There was a fantastic blend of youth and experience, many young blokes learnt many things about umpiring from the older guys, not to mention Greg and myself handing out some lessons and some hidings to the young blokes on the pool table. Don't worry guys your day will come.

The expenses themselves are pretty self explanatory. Committee entertainment is usually a common question as the Executive should not enjoy themselves too much. The total expense represented sponsors lunches with AMPOL and Taylor Woodings, lunch with Grand Final Umpires' Club Master of Ceremonies, Brad Hardie and attendance by the Executive at the Life Members' Dinner. I will be happy to field any further questions that members may have.

Those members with a eye for detail will notice a significant change in the presentation of the accounts from last year. In short I proposed

to the Management Committee, which they accepted, that the basis of accounting be changed from an accruals basis to a cash basis. This is common for many small organisations as the only things that is important is the cash coming in and the cash going out. This eliminates the need for a balance sheet as all items of plant and equipment and stock are expensed immediately. For 1996 all items in the cash flow statement represent cash actually paid and cash received.

1995 comparatives are the same as last year and have not been adjusted because the net effect of any adjustments is only \$207, which represent non-cash entries in any case. The 1996 figures represent cash received and cash paid for the period 16 October 1995 to 15 October 1996. These adjustments have been discussed and agreed with the auditor.

I have enjoyed my time as Treasurer in 1996 and my time on the Management Committee for the last five years, the last two on the Executive. I have some rather pressing out-of-umpiring commitments that do not allow me the same amount of flexibility to commit time to the Association like I have in recent times. Therefore I am not seeking any positions on the Management Committee in 1997 but I have made it clear that my commitment to the Association and the Management Committee has not diminished.

I wish everyone the very best wishes for 1997. Keep happy and healthy and remember that the Association is great only because it is full of great people.

Unfortunately we cannot maintain the current level of spending as it is obvious that our surplus funds would not be sufficient.



State Director's Report

Gentlemen, it is with pleasure that I report on yet another successful football season and take this opportunity to acknowledge your contribution to this ongoing success.

Structure

I have included the W.A. Umpiring structure diagram at the conclusion of this report, as it is apparent we all benefit from knowing or understanding the so-called big picture and our role within it. As you can see our umpiring needs have increased as football continues to grow. As football becomes more professional, so too must be the delivery of our service.

Recruitment

Eight new Field Umpires commenced this year as a result of the newly formed Talent Squad Summer School Program. 21 enrolled and 17 successfully completed the program. From this squad 7 were named on the WAFL list and look certain to have an impact on WAFL umpiring in years to come. It is anticipated a further 5 are required to set us in good stead in 1997. The 96/ 97 squad is currently being formed for a November 4 start. 9 new boundaries had a taste of WAFL umpiring although only 3 appear they will continue on and 7 goal umpires were new in 1996 and look set for bright futures. One area often neglected in terms of recognition is the recruitment of off field support staff and it may surprise that the number of trainers, observers, coaches, RUMS, medical, video and selectors etc. total 34. I personally thank each and every one of them for giving of their time and knowledge to assist in your development.

Promotion

Whilst not actually recording every piece of publicity afforded to umpiring this year, one can assume there was a noted increase in positive umpire reporting. Perhaps some type of record needs to occur in 1997 to substantiate these claims. WAFL umpiring enjoyed support from radio 6NR weekly with after match interviews and I see two benefits from this initiative. Firstly, the opportunity to put our case forward and secondly the development of individuals as they learn to manage and cope with this extra scrutiny. Westside Football was very generous in their coverage and both the West Australian and Sunday Times featured articles on WAFL umpiring. Bearing in mind WAFL does not command the coverage afforded ten years ago, so we have done particularly well. The inaugural Footy Fest held in conjunction with the W.A. V



S.A. State Match in July, saw our enthusiastic approach rewarded with clearly the best prepared and presented display on show. It is anticipated this will become an annual event. Members of your association should be congratulated on a truly magnificent effort. I thank you very much.

Retention

Four of the six Junior Region Coaches and Assistants are ex WAFL umpires which is a credit to these guys as this area is by far the hardest of all key areas to address. At the risk of repeating my '95 comments, too many umpires finish their careers with anger in their hearts at not realising their dreams and cast blame at coaching staff and observers on feedback or lack of it, yet when approached to help someone else they flee often faster than any 4km time previously set. Football umpiring needs the input of experienced umpires and I plead for assistance in this area, not criticism. Having experienced both sides of the coin, a great deal of satisfaction is felt when you witness the improvement achieved by your input and support to those willing to head your advice.

Coaching

This year saw the appointment of separate umpire coaches to all three disciplines, and whilst some senior umpires feel new coaches need time to gain acceptance, that time is theirs that they are wasting. John in his first year as Senior Coach must be very pleased with the results. He not only maintained our existing standard, but also witnessed 3 new League umpires, 2 new Grand Final umpires, 1 State Umpire and the

development of new WAFL umpires with their rapid transition from Junior umpiring to Senior football. John clearly knows the direction we are heading and will be wiser from the knowledge gained this year. Leith Putland leaves Boundary umpiring after 3 years and would be the first to admit that '96 would be a year he would rather forget. Work commitments prevented Leith from building on the success of his previous 2 years, and this should act as a reminder to all, how fragile umpiring can be and just how much work is required to maintain an acceptable service. Leith is to be congratulated for his work with WAFL Boundary umpires and we wish him well in his football retirement. Goal umpiring, whilst not facing a number shortage had to deal with a new type of scrutiny that many found made a difficult task, even more difficult. Roy and Gil worked tirelessly to ensure we built on last year's success and must be pleased with the potential that was unearthed this year. W.A. has had an AFL Finals representative in each of Roy's three years with us, indicating Goal umpiring is heading in a good direction.

Accreditation

The National Accreditation Scheme spread its tentacles even further with the inclusion of Boundary and Goal umpires at Level One. The NAS is currently being re-formatted into the competency based training concept and when complete offers umpiring the best resource of any sport in Australia. We need to acknowledge that this resource will remain for many years as our flagship in umpire development.

Facilities

Since your move to South Perth, there has developed a responsible management committee that has the best interests of this association driving it forward. The move was a decision that was not greeted all that enthusiastically in 1993 but indications are this is changing as we now host a training venue that is in our control. The photographs acknowledge and have enhanced the Honour Boards in umpire recognition and vindicate the substantial financial commitment from the West Australian Football Commission. Our 1997 objective is to address the coaching aspect and we are currently waiting for a positive response on a \$ 40,000

grant to extend the facility with an improved coaching venue. February has been indicated as the announcement date as to our success.

Sponsorship

We are fortunate to have retained the generous support of AMPOL for a further two years as a result of the three year deal struck in February this year. The prospect of losing our valuable friend and partner of eighteen years, led to frantic discussion's pre-season and if not for the efforts of Ross Benzie I can assure you W.A. umpiring would have suffered a great loss. Through discussions with your Executive, I propose during the off season to formulate a new set of strategies aimed at servicing not only AMPOL but all our sponsors at a level they so richly deserve.

Conclusion

Umpiring in Western Australia has achieved so much in recent years and many can feel content in their contribution to this result. It is vital you also know what our plans are for the next three years, so I will complete this report with a few thoughts that we hope with proper planning will become reality in the not too distant future.

- A nationally coordinated promotional campaign.
- A West Australian umpiring academy based at either Ernest Johnson or Subiaco Oval by the end of 1997.
- A fourth Regional Umpiring Manager to service our North West.
- A National Umpires Coaching Accreditation Scheme (Levels 1-3).
- Umpires wired up so communication can occur during the match.
- Trial by video implemented into the WAFL.

My congratulations to your committee on another fine year and I look forward to planning 1997 with your co-operation and ongoing support.

Field Umpires Coach Report

It was with a great sense of challenge that I agreed in 1995 to accept the position of State League coach of field umpires. I can say now that the challenge was all that I had expected and more. My role has been made easier due to the excellent support I have received throughout the year from Max Osborn, Derrick Ernst and David Johnson.

The season began with pre-season training sessions designed to bring umpires to an acceptable state of fitness and the Rottnest Camp under the theme "Knowledge of the Laws". This was my first disappointment, and future camps will be designed around a development of umpires and not a social occasion.

Apart from this one issue I have enjoyed greatly the season and the challenges placed before me in maintaining and improving the standard of field umpiring within the WAFL.

We have continued with the Three Umpire System in league games and this has given an opportunity for younger umpires to display their talents and get a feel for umpiring at the highest level within the WAFL. I have been able to introduce three (3) new umpires to league ranks and all performed well at different times during the season. The first to show he was ready for league football was Chris Slocombe who umpired well throughout the Emu Export Cup and finished the season with twelve (12) league games. Later in the year Mark Fussell and Craig Hendrie were given an opportunity and both performed very well achieving thirteen (13) and twelve (12) games respectfully. Both also being appointed to umpire the Colts grand final. Overall seventeen (17) umpires were utilised in league games throughout the season, and a total of thirty five (35) umpires performed in all games in the WAFL.

Some of the talent identified in 1995 developed to a stage of umpiring at reserves level and performing to a very high standard while others continued at Colts level also achieving very high standards. Once again in 1996 we have identified more exciting umpires



for the future. Umpires such as Glen Howie, Jeff Petrie, David Panagopolous and Glen McIvor have all demonstrated that they have the ability to achieve at the highest levels, it will be their task to convert that potential into reality.

Some notable achievements were made throughout the season in field umpiring. Sam Kronja umpired his 150th league game and continues to show that he has the ability to umpire at the highest level on a consistent basis. He also umpired 3 games during 1996 in the AFL. Peter Repper also umpired his 150th league game. Peter continues to umpire on a very high standard and provides valuable support on the field to younger umpires. Adam Binks umpired his 50th league game and has shown in 1996 that he is capable of better things. He has been rewarded for his high work ethic in 1996 with his first league Grand Final. Darren Starcevich umpired his 50th league game and although not reaching the highs of 1995, has continued to umpire well within the WAFL.

The Umpires of the Rounds were:-

Round 1 Wayne French Round 2 Murray O'Dea Round 3 Trevor Garrett

All had a very good season in 1996, both Wayne and Trevor were extremely consistent

throughout, while Murray after a poor first round finished the year strongly being the Western Australian representative in the Australian Schoolboy Championships in Melbourne.

The Field Umpire of the year award was won by Sam Kronja, who has had another outstanding year, umpiring in his fourth consecutive Grand Final and umpiring three (3) AFL games during the season. The Most Improved Field Umpire Award was won by Adam Binks who in 1996 has displayed a very high level of consistent umpiring and in just over 50 games has achieved his first League Grand Final.

1996 also saw eleven (11) field umpires undertake the level 4 Accreditation Scheme which was integrated with the other formal coaching session being conducted on Tuesdays and Thursdays. While this required an additional commitment from those umpires, all benefited greatly and three (3) umpires Aaron Capes, Adam Binks and Murray O'Dea were successful in achieving level 4 Accreditation. Those who did not succeed in 1995 will undergo the program again in 1996 with the addition of those level 3 umpires identified for future development. I would like to thank Wayne French, Sam Kronja, Greg Scroop, Robbie Hendrie and Darren Starcevich for their assistance in presenting units of the course. Derek Ernst also conducted a Level 3 Accreditation Scheme for umpires who had progressed to Level 2.

When we commenced the 1996 season I set some goals regarding performance standards and umpiring the decisional accuracy of league umpires in particular, but across all grades generally. While not achieving the improved decision accuracy levels planned in league

football, we have been able to maintain those levels set in 1995. Significantly, greater emphasis is being placed on the development of skills such as, control, observation, set plays and positioning. In 1996 a new rating system was developed that calculated the umpires rating on a weekly and seasonal basis, taking into account decisional accuracy, severity of minimal frees, skill errors and bouncing. While the system still requires some further refinement, it has assisted greatly in determining an overall rating for each umpire. Interestingly we also referred to the 1995 rating system to test the new scheme and with only minor discrepancies the two system ratings matched.

Overall I found the season an enjoyable one and look forward to 1997 with renewed enthusiasm to further improve the service that umpires deliver to football in Western Australia.

I would finally like to thank all of those who have assisted me throughout the season, especially Max Osborn, Derreck Ernst, David Johnson and Kevin Castensen. I would also like to thank Gail for her support and understanding during the season.

Export Cup matches. The umpires who umpired in all these matches did a fantastic job and a special vote of thanks to those who travelled far and wide to officiate. Congratulations to those Grand Final umpires selected on their performances during pre-season, Greg Smith and Troy Starcevich, you thoroughly deserved your selection.

State games are always a highlight in any umpires career and therefore much sought after. 1996 provided an opportunity for both AFL and WAFL umpires to gain selection in interstate games. Dan Gooch was appointed to umpire in Melbourne for the State of Origin game between Victoria and the Allies. Umpiring Development Report

Regional Umpiring Managers' Program

The Regional Umpiring Managers' (RUM) Program is now in its second year and continues to service 16 country leagues within three regions of the State.

Robert Forbes (Southern Region) was appointed to carry on the good work of his predecessor Darryl Carpenter and Noel Morgan (Central Region) and Kevin Waycott (Northern Region) were reappointed for a second term.

Their role is to manage and assist umpires coaches in the development and servicing of umpiring panels in each League of their Region.

In February at the Annual Coaches Camp at Bickley, we saw the National Accreditation Scheme, Level One Umpires Advisers Certificate Course implemented for the first time, with each RUM attending and successfully completing their accreditation.

The Regional Umpiring Managers Program is vital for the development of umpiring in our country regions and the contribution of the work carried out by the RUMS this year can only enhance its success.

Country Panel

The composition of the Country Panel consisted of 16 WAFL and 3 WAAFL young and experienced umpires participating in 4 of our country leagues. Upper Great Southern, Central Midlands Coastal, Lower South West and the Eastern Districts requested our services again and match payments increased to \$110 (under 250km) and \$125 (over 250km) with corresponding Final fees of \$125 and \$160 and Grand Final fees of \$170 and \$200.

Feed back from all Country Leagues were generally very complimentary and rewards for effort and performance reflected in the Grand Final appointments of:-

Brendan Marsh and Chris Paterson to the Central Midlands Football League, Andrew Neale to the Lower South West Football League,



Jeff Petrie to the Upper Great Southern Football League and Simon Gill to the Eastern Districts Football League. Fine performances came from Nathan Nicholson, Gavin Levitske. Murray O'Dea, Slavko Mutavdzic (WAAFL) and the flying Luke Rewega in their appointments to the lead up finals. Congratulations and well done.

Good performances throughout the year also came from Robert Butler, Steve Akker. Gavin Statham, Gregor McQueen, Glen McIvor, Peter Quigley, Doug Cornish, Michael Parkes (WAAFL) and evergreen Ray Zoch (WAAFL).

Participating in Country Football has always been a rewarding experience for any umpire seeking to develop the skills, knowledge and management aspects of their game. Your contribution to the development of country panel umpires and your cooperation throughout the season has been greatly appreciated by the Country Leagues and the West Australian Football Commission.

AFL Report Grand Final Breakthrough

Dan Gooch became the first ever West Australian to officiate in an AFL Grand Final when he stepped onto the MCG on the last Saturday in September - and what better occasion than the Centenary AFL Grand Final between North Melbourne and the Sydney Swans and a crowd of 95,000.

Dan was also the first boundary umpire from outside of Victoria to officiate in the Grand Final. At just 22 years of age, this is an outstanding achievement and surely the highlight of the AFL season for WANFLUA members.

Grant Vernon, who returned to Perth early in the season came close to joining Dan when he was appointed as Emergency Field Umpire for the Grand Final - but alas no cigar!

Greg Scroop (Field Umpire) and Peter Jeffers (Goal Umpire) must also have been pressing for selection in the Grand Final after strong performances through the season and particularly the finals series. After 10 years of trying, this year was clearly WA's best in terms of performances at AFL level.

As mentioned, 1996 was the Centenary Season for the AFL and there were many highlights for umpires from West Australia:

Three West Australians made their debuts at AFL level during 1996. Sam Kronja finally broke through and was rewarded for several years of hard work and perseverance late in the season with a debut in the St. Kilda versus Geelong match at Waverley. Andrew Curtis and Greg Smith had opportunities earlier in the season.

The AFL is increasingly competitive and congratulations are extended to those who won

selection for the first time in 1996. As always, the greater challenge is now to consolidate in the coming season.

A Centenary Dinner was conducted by the AFL for umpires who had officiated in 25 or more senior games. Several West Australians including Mike Ball and Roy Ferguson attended what was a very special event.

At an administrative level, the AFLUA continues to move forward. Grant Vernon retired as President of the AFLUA having completed a restructure of the Association management. That restructure was critical to the professional development of the Association and to our negotiating capacity for terms and conditions. It is a foundation to work from for many years to come.

As this report is being written. AFLUA representatives are close to finalising a 3 year deal with the AFL which will deliver significant increases in remuneration for AFL Umpires as well as the security of more substantial base payments for signing on - rather than being solely dependent on match payments.

West Australians should be proud that we have made such a significant contribution to the future welfare of umpires at AFL level.

1997 is a season that we should be very optimistic about. If our senior AFL umpires in all categories can continue to perform strongly and younger talent in our ranks can push through, then next year we may finally see even greater influence on the AFL scene from WA based umpires.



Hall of Fame

The 1995 year saw the introduction of an award that is now one of the most prestigious umpiring trophies - the Western Australian National Football League Umpires Association 'Hall of Fame'.

The idea of an umpiring Hall of Fame was initiated by the President of the Umpires Association, Greg Scroop, and was subsequently endorsed by the 1995 Management Committee. In keeping with the prestigious nature of the award, only one umpire from each umpiring discipline was selected in 1996.

The 1996 Hall of Fame subcommittee consisted of Tim Priest (chairman), John Hauswirth, Dan Gooch and Brett Wallington. In presenting names to the Management Committee, the subcommittee was guided by two criteria:

- 1. Candidates need to have been retired from umpiring.
- 2. Candidates need to have demonstrated outstanding achievement as an umpire during their careers.

Once researched, the subcommittee selected four former umpires from each discipline. After much deliberation the subcommittee then put forward its recommendations to the Management Committee for a final decision.

Joining the 6 inaugural inductees from 1995, this year we have Mike Ball (Field Umpire), David Aslett (Boundary Umpire) and Roy Becker (Goal Umpire). Each inductee was presented with his caricature at the 'Hall of Fame' night held at Ernest Johnson.

Mike, David and Roy are all widely accepted as worthy inductees to the Hall of Fame. Together with the 6 foundation Hall of Famers, their caricatures will forever hang on the clubroom walls as an acknowledgment amongst Association members of their excellence in umpiring.



Taylor Woodings Sponsorship

The committee of the WANFLUA and Taylor Woodings continued their sponsorship agreement during 1996. For the benefit of new members of the WANFLUA we have outlined details of the agreement below.

Taylor Woodings has met the cost of developing and providing the training uniform jumpers for the 1996 season. All umpires were provided with one jumper, 1 T shirt and 1 pair of running shorts at a cost to Taylor Woodings of \$7215. In addition, Taylor Woodings was top provide \$1000 to the WANFLUA on presentation of the uniforms for the running of the WANFLUA in 1996. Over and above this initial sponsorship a cash incentive structure was put in place as follows:

- \$250 to the WANFLUA on \$10000 in fees received by Taylor Woodings as a result of referrals by members, relatives, friends or acquaintances of the WANFLUA prior to the completion of the 1996 football season;
- \$500 on receipt of a further \$10000 in fees;
- \$750 on receipt of a further \$10000 in fees:
- \$1000 on receipt of a further \$10000 in fees;

At the time of writing of this report, the Umpires Association had received a total sponsorship of \$8215 for the 1996 season.

In return the Umpires Association agreed to :

- adopt the Taylor Woodings uniform as the official and compulsorily worn uniform of the members of the WANFLUA at training in 1996;
- provide a forum for Taylor Woodings to launch their sponsorship;
- promote Taylor Woodings services on presentation of the training uniform;
- provide Taylor Woodings with the name, address, age, telephone number and occupation of all members of the WANFLUA, including Life Members for inclusion by Taylor Woodings on client mailing lists, seminar and function invitation lists and to expand the Taylor Woodings client base network;
- grant first option to Taylor Woodings to acquire exclusive naming rights to the WANFLUA training uniform in 1997 and if the option is taken up, a further option be granted by the WANFLUA to Taylor Woodings for 1998;
- · through the President, make members aware

of the cash incentives the WANFLUA receives if the members support Taylor Woodings financially.





Obituary – Fred Woods

Woods was leading umpire and TV doyen

Former WA football umpire and commentator Fred Woods, 69, died in his sleep on Friday night.

Woods umpired between 1950 and 1965 officiating in a Grand Final and State games but is probably best remembered as 'The Judge' on Channel 7's World of Football in the late 1960's and 1970's.

His outspoken views were the mainstay of a show that ran for more than a decade and turned former champion players Frank Sparrow, Percy Johnson, Steve Marsh, Mick Cronin and Marty McDonnell into household names.

Woods always took the side of the umpires and became the man everyone loved to hate.

But he did speak with authority. He was widely regarded as one of the state's best officials. In his final season, 1965, he was rewarded for his services to the game by officiating at the 1965 grand final.

He also became the first West Australian to umpire an interstate match between Victoria and South Australia in 1965. He was made a Life Member of the WANFLUA in 1967.

McDonnell, who coached South Fremantle from 1960-1963, said yesterday that Woods was one of the most respected men in the game. 'He was also a great personality and was enormous value as a TV presenter and radio commentator.' McDonnell said.

After football Woods turned his interest to trotting and lawn bowls. He was a member of the Osborne Park Bowling Club for 30 years and was its President between 1991-1993. During his time at the helm, he was one of the driving forces behind the clubs massive extensions and improved on field performance.

His association with WA trotting was almost as long - as an owner with the successful Trevor Warwick stable. His last horse was 4 year old Riwaka Vance which won at Pinjarra last Monday. Woods and co-owner Cam McNab were at the track to see the horse race. Riwaka Vance has won 15 races and was Woods' most successful pacer.

Woods, who will be cremated at Karrakatta on Wednesday, leaves a widow Natalie and 3 children Greg, Jennifer and Deborah.
